Big Darby Accord Working Group

The Big Darby Accord Working Group has met twice since your last Trustees meeting and focused most of its attention on Town Center implementation discussions. The largest hurdles to be overcome in implementation of the Town Center involve infrastructure, land assembly, and schools.

Concerning infrastructure, there has been productive discussion between the Town Center implementation consultant team and the Franklin County Sanitary Engineer about some of the funding and some of the work the Sanitary Engineer intended to do on alternative wastewater treatment and drinking water being folded into the Town Center implementation activities. The idea is to move that work forward to provide timely answers for the Town Center work and to provide meaningful information to the Sanitary Engineer's Office. Discussions continue.

Concerning land assembly, the consultants have spoken with representatives of the Galbreath interests and have a face-to-face meeting with Lizanne Galbreath scheduled for March 31 to pursue their interest in participating in the Town Center.

It is recognized that a solution to the schools situation needs to be proposed before the consultant contract is complete.

Staff members of County Commissioners O'Grady and Brown have been briefed on the progress of the Town Center implementation work.

Scheduled Agenda Item: Annual Permanent Appropriations Resolution

Fiscal Officer Ruwe previously provided the Trustees with Draft Resolution 2-2014, Annual Permanent Appropriation Resolution. The Detail Report attached to the Resolution proposed to appropriate the following amounts to the six Township Revenue Funds: General Fund - \$360,000; Motor Vehicle License Tax - \$10,000; Gasoline Tax - \$360,000; Road & Bridge Fund - \$27,000; Fire Operating Fund - \$629,066; and Permissive Motor Vehicle License Tax - \$30,000. The amount of the appropriations detailed to be appropriated for the six funds totals \$1,416,066.

Trustee Sayre moved the adoption of Resolution 2-2014 (03-17) as proposed. Trustee Dever seconded the Resolution. The roll was called and the voting results were: Dever: aye, Sayre: aye, Martin: aye. The Resolution and appropriated funds were adopted effective immediately.

Fire Levy Discussion

Resident Tim Shade who chairs the Safety First Committee in support of Issue 20, the Brown Township Fire Levy, was in attendance and made a presentation. Tim reported that the committee has developed a plan to support Issue 20. Six large plywood signs have/will be placed throughout Brown Township in key locations. Two hundred fifty yard signs have been ordered. Communications with township residents have been developed. These communications include postcards to be mailed on two different dates, a pamphlet and a FAQ sheet. Tim also reported that a resident stated (at one of the weekly committee meetings - Thursdays at 6:30 in the Twp. Admin office) that personal safety was an important consideration when he decided to move to Brown Township.
