#### Franklin County Sheriff Report

Deputy Jessie Hatfield was in attendance and reported on FCSO activity in the township since our last meeting. He said that the FCSO received seven reports during that period of time. One incident involved the theft of a firearm stolen from a vehicle on Amity Road. Deputy Hatfield said that he received a call concerning occupants at Walker and Scioto Darby Roads. The call was referred to Netcare.

#### Norwich Fire Department Report

Chief Warren was in attendance and presented the Incidents Report for October, 2017. During the month, there were (22) EMS runs and (2) Fire runs in Brown Township. Chief Warren wanted to express his appreciation of the Franklin County Sheriff's Department. Due to an incident at a Norwich Township fire station involving a very high carbon monoxide level, a reporting system is needed. An estimate for such a system was presented from Koorsen Fire & Security. It was also noted that the CPR workshop held in the township hall went very well and the fireman who led the workshop was commended.

### Beth Clark's Report

#### HILL FARM REZONING PROPOSAL

At its November 14 meeting, the Big Darby Accord Advisory Panel recommended approval, by a vote of 4-3, of a proposal for rezoning on Hill Farm property in the City of Hilliard. The proposal is for rezoning into the Hilliard Conservation District zoning category. The site consists of two parcels totaling about 207 acres. One of the parcels – about 43 acres – is not within the City of Hilliard and cannot he annexed. That property is included as open space in the density and open space calculations. 229 single family homes are proposed. A three-acre parcel at the corner of Scioto Darby Creek Road and Langton Road is proposed to be reserved for a fire station. Concerns raised by Panel members voting no appeared to center on the inclusion of land outside Hilliard in the density calculation and inclusion of manicured lawn areas as part of the density calculation. Those voting yes appeared to be persuaded by the developer's attorney's assertion that including land outside Hilliard is effectively a transfer of development rights, something he said the Accord supports. The case is tentatively scheduled for the December 14 meeting of the Hilliard Planning and Zoning Commission.

Additionally, Hilliard staff distributed a spreadsheet at the Accord Panel meeting which summarizes information associated with Hilliard's use of the 2000 equivalent residential units of sewer capacity available to them under agreement with Columbus. Staff indicated the 2000 cap has been reached with this proposal. (I have provided the spreadsheet to Trustees.)

#### CENTRAL OHIO GREENWAYS

Kerstin Carr (MORPC) and Letty Schamp (Hilliard) will attend the December 18 Board of Trustees meeting to discuss Central Ohio Greenways with particular attention to proposals in the northwest part of Franklin County. Trustees requested this presentation after discussion of greenways at the September intergovernmental meeting.


